NEW BUSINESS

1. PUBLIC HEARING: 5 Beatty Ave., Baylands Soil Processing Site; Use Permit UP-3-14; Temporary Use Permit to allow for the use of the Baylands Soil Processing site to demonstrate Peterson Cat earth moving equipment; Peterson Cat, applicant; Universal Paragon Corp., owner; APN's 005-340-050, 005-350-080, 005-350-020 & 005-162-300.

Senior Planner Johnson gave the agenda report and presentation. He answered questions from Commissioners regarding dust control and limitations on disturbing the soil cap. Chair Cunningham opened the public hearing and the Commission accepted public comment from Wayne Hendricks. Howard Pearson, property owner representative, and Johan Larson, applicant, answered questions from the Commission regarding the amount of soil to be moved and the purpose of the demonstration.
