#### **RECOMMENDATION:**

Consider approval BDW Holiday Arts and Crafts Fair Fundraiser as a co-sponsored event.

#### BACKGROUND:

BDW will present the Holiday Arts and Crafts Fair on December 12, 2015. Arts and Crafts people from Brisbane and surrounding area will be selling their wares.
