Subject: Applications for Event Co-Sponsorship

#### **RECOMMENDATION:**

Consider approval for use of Lipman Field by Brisbane Youth Sports Association for the Summer Soccer Camp from June 15, 2015 to June 26, 2015. They are asking that the fee for use of the field be waived. Normally, a local non-profit organization would be charged \$15 an hour. Given this, the program would use the field for approximately 80 hours making the total cost \$1,200.00. No city staff is necessary for this program. No other expenses will be incurred.
