
Subject: Applications for Event Co-Sponsorship

RECOMMENDATION:

Consider approval for use of Brisbane Elementary Field by Brisbane Youth Sports Association (or Mission Blue Field or Lipman Field) for the "Fun Motion Soccer Program" March 21 – June 16, 2015. They are asking that the fee for use of the field be waived. Normally, a local non-profit organization would be charged \$15 an hour. Given this, the program would use the field for approximately 28 hours making the total cost \$420.00. No city staff is necessary for this program. No other expenses will be incurred.
