SUBJECT: Construction Contract for the Bayshore Corridor North South Bikeway Project Phase II

DATE: March 21, 2011

### **City Council Goals:**

To promote transportation opportunities that maximize safety, reliability, enhance circulation and create options thereby reducing reliance on the use of the automobile. (#5)

### **Purpose:**

To provide for an extension of existing bicycle lane and thus to encourage increased bicycle travel along Bayshore Boulevard from Valley Drive to the northern city limits.

### **Recommendation:**

Award the construction contract for the Bayshore Corridor North South Bikeway Project (#9B01) to Granite Rock Company, dba Pavex Construction Division, Inc. in the amount of \$453,702, and authorize the Mayor to sign the Agreement on behalf of the City.

### **Background:**

Council approved the concept for this project in 2005. In 2007 the city received funding for and constructed Phase I, the southerly portion of Class II bike lane along Bayshore Blvd.

At Council's April 5, 2010 meeting, Resolution No. 2010-17 agreeing to comply with the Metropolitan Transportation Commission's adopted laws and procedures in order to allocate funding for Phase II was passed. Funds were encumbered in December, 2010. Staff completed construction documents and brought them to Council on February 7, 2011 to receive approval of documents and to publish the Notice Inviting Bids.

Utilizing state Transportation Enhancement funds, this construction project will install Class II bike lanes on Bayshore Boulevard from Valley Drive to the northern city limits. The modifications include signs, repaving, restriping, concrete median barriers and end treatments.

**Discussion:**

The City received the following bids on March 10, 2011:

Staff reviewed the apparent low bid and determined that the proposal was responsive and the bidder was responsible.

**Fiscal Impact:**


\$710,895 of federal Transportation Enhancement Funds together with \$92,105 in state matching funds are allocated in FY10-11’s CIP for this project.

Construction of a Class II bikeway along Bayshore Boulevard from Valley Drive to the northern city limits that provides the public with the opportunity to safely bicycle along Bayshore Boulevard.
