PURPOSE:

To support BDW's Spring Performance which may be enjoyed by all Brisbane residents.

RECOMMENDATION:

Consider approval of Brisbane Dance Workshop Annual Spring Performances as a co-sponsored event in the Mission Blue Center on May 17 and 18, 2014. An additional cost has been added to the Co-sponsorship this year. In the past, the city has funded only \$500 toward the total cost of lighting design by Phoebus Lighting. This year BDW is asking the city to pay the total cost. This then allows BDW to pay for two high school interns to training with Phoebus to learn how to run the lights for the event. Also please note on the application, alcohol will be served but not sold, so therefore, a permit to sell alcohol is not required.
