A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRISBANE ADOPTING COUNTY OF SAN MATEO CERTIFICATION OF VOTES AND DECLARING RESULTS TO FILL THREE COUNCIL SEATS AT THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 5, 2013

- 2. That the record of votes cast in said election including absent voter ballots, is shown on Exhibit "A" of the Certificate of the Chief Elections Official, attached hereto, and by such reference made a part hereof.
- 3. That W. Clarke Conway, Cliff Lentz, & Lori S. Liu were elected to fill the offices of Councilmember for a term ending in 2017 and the City Clerk is hereby directed to issue a Certificate of Election to the persons, certifying each person's election to the office appearing after his or her name, and to administer to the elected persons the oath of office prescribed by the Constitution of the laws of the State of California.
