D. Consider motions to fill vacancies

After interviewing the applicants present, CM Conway made a motion to re-appoint both Bonnie Bologoff and Renee Marmion to the Parks and Recreation Commission for a term of 4-years. CM Miller made a motion, seconded by CM Conway, to appoint both Karen Akiko Lentz and Kevin Fryer to the 2-year terms.

Councilmembers discussed expanding the Parks and Recreation Commission to seven members to allow appointment of Jamesanne Dunn to a 4-year term and to interview Bill Miller for the 2-year term on the next available date. They indicated that these appointments could not be made until a change in the Commission number was effective by ordinance.

CM Richardson made a motion, seconded by CM Conway, to direct staff to bring back an ordinance amendment allowing for seven members to serve on the Parks and Recreation Commission and to propose an action to deal with Commission/Committee attendance. The motion was carried unanimously by all present.

It was the consensus of the Council to agendaize the appointments of Council liaisons to all City Commissions and Committees to allow for better communication.
