#### 7:30 P.M. CALL TO ORDER - FLAG SALUTE

Mayor Miller called the meeting to order at 7:33p.m. and led the flag salute.

# A. Allen Edwards – Marina Dredging

Mr. Allen Edwards gave a presentation on the need for dredging at the Brisbane Marina.

Mr. Edwards said that he was a member of the Sierra Point Yacht Club and that he has had his boat at the marina for many years and made many friends there. He outlined how deep marinas should be, how deep the Brisbane Marina was now, how much dredging was needed, the cost of the dredging, how long it would take, and the cost of not getting the dredging done now.

After Councilmember questions and clarifications, they thanked Mr. Edwards for his informative presentation and indicated that a Council Facilities Subcommittee would be meeting soon to continue to study the Marina's Capital needs, including dredging. They indicated that there was \$10,000 in the proposed budget to study this issue.
