SUBJECT: Surplus of Police Vehicle

## RECOMMENDATION:

We recommend that the City Council consider Resolution #2012-38, DECLARING CERTAIN PROPERTY SURPLUS AND PROVIDING FOR THE DISPOSAL OF SUCH. We request you approve this resolution to surplus one of our older patrol cars and move to dispose of it through public auction at Property Room.com Inc. in Hayward.

## BACKGROUND:

The vehicle in question is a 2008 Ford Crown Victoria, VIN 2FAFP71V18X167690, with mileage of 81,884. The vehicle runs, but has several electrical issues and has reached the end of its useful lifespan.


## DISCUSSION:

This vehicle has reached a point where it will no longer be cost effective to repair and maintain the problems that are immanent with a vehicle of this age and mileage. We normally cycle out vehicles at between 75,000 and 80,000 miles, at which time they have surpassed their useful life. At 81,884 miles, continuing to maintain this vehicle would not give us a satisfactory return on our maintenance investment.

## FISCAL IMPACT/FINANCING ISSUES:

All monies received from the sale of this surplus vehicle through the auction process will be deposited into the General Fund.
