WHEREAS, a General Municipal Election was held in and throughout the City of Brisbane on the third day of November, 2009, to submit the candidates to fill three Council seats for four-year terms, to the qualified electors; and

WHEREAS, the City Clerk of said City has duly posted and presented to the City Council of the City of Brisbane the County of San Mateo's certification of the votes cast in Consolidated Precincts 1, 2 and 3, in said General Municipal Election; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Brisbane finds as follows:

- 1. The number of votes cast at Consolidated Precinct No. 1 was 355; the number of votes cast at Consolidated Precinct No. 2 was 343; the number of votes cast at Consolidated Precinct No. 3 was 170; to make the total number of votes cast in said election to be 868.
- 2. That the record of votes cast in said election including absent voter ballots, is shown on Exhibit "A" of the Certificate of the Chief Elections Official, attached hereto, and by such reference made a part hereof.
- 3. That W. Clarke Conway, Clifford R. Lentz, and A. Sepi Richardson were elected to fill the offices of Councilmember for a term ending in 2012.
