### **Renovation of Community Center through Rebuilding Together Peninsula**

### <u>Community Park Playground Upgrade – PowerPoint Presentation</u>

Administrative Management Analyst Cheung gave a PowerPoint presentation updating the Commission on funding (grants) opportunities. She also presented samples of play structure designs based on desired elements, colors and materials discussed at the November 16, 2011 P&R Commission Meeting.

David Yosso from Miracle Play Systems was available to answer questions regarding play structure elements and materials.

Members of the community commented on the proposed play structures.

Chairperson Hart moved, seconded by Commissioner Bologoff, to establish a Community Park Playground subcommittee and he nominated Commissioners Marmion and Bologoff to serve on the subcommittee. The motion carried 3-0.

### **Potential Farmers Market in Brisbane**

farmers' market in the Brisbane Community Park to run on Thursday afternoons from approximately 3:00pm - 7:00pm in the summer and 2:00pm - 5:30pm in the winter.

The Commission discussed potential damages to the park, possible other locations, and the impact (such as parking) on the downtown area. Director Schillinger suggested an evaluation after a three-month period.

Commissioner Bologoff moved, seconded by Commissioner Marmion, to support the farmers market in Brisbane with the following stipulations: 1. removal of all trash, 2. hot food vendors limited to Brisbane businesses, 3. placement of mats and tents during rainy weather, and 4. three-month trial period at a cost of \$200 per week. The motion carried 3-0.
