BES Restroom Project – status

Parks and Recreation Director Skeels reported that the City should have bids from two contractors, for the installation of the BES restroom, by the end of the week.

Community Park Play Equipment – status

Parks and Recreation Director Skeels reported that the Lions Club is not interested in participating in a financial contribution on the project; however, they would consider assisting with installation. He added that the City will also evaluate possibly revising the project as well as to consider other fund-raising ideas.

Seton Medical Foundation "Get Healthy" Funds – update
