PUBLIC HEARING: 786 Humboldt Road; Variance V-3-14; Variance to allow for a lot line adjustment between the existing buildable vacant lots at 786 and 788 Humboldt Road to; 1) reduce the lot width of 786 Humboldt Road to approximately 37.5 feet, where 50 feet would otherwise be required, and 2) reduce the lot area of 786 Humboldt Road to 4,244 sq. ft., where 5,000 sq. ft. would be required; Dave Bostrom, applicant/owner; APN 007-432-320.

Commissioner Parker moved and Commissioner Reinhardt seconded to continue the public hearing of Variance V-3-14 to the next regular meeting of February 26, 2015 due to lack of a quorum to hear the item. The motion carried 3-0.
