1. Inclusionary Zoning and Density Bonus Ordinance

Associate Planner Ayres gave the staff presentation outlining the current inclusionary housing and density bonus ordinance (BMC Chapter 17.31), new State requirements, and proposed areas of the ordinance to be updated consistent with the new State requirements.

Staff and the Commission discussed alternative options to providing on-site inclusionary housing units allowed under State law. The Commission requested that staff bring back information on alternatives to providing on-site inclusionary units and commercial/residential development linkage fees adopted by other local jurisdictions at a future workshop.

Senior Planner Johnson gave the staff presentation outlining the primary areas of interest in a parking ordinance amendment, including a comprehensive update of the Ordinance's structure and organization and parking requirements for non-residential land uses. Staff indicated they would bring back specific standards for non-residential land uses as well as proposals for restructuring the ordinance at future workshops.
