1. Staff presentation on 2019 California Building Code update and local "reach codes".

Senior Planner Johnson gave the staff presentation. The Commissioners and staff discussed electric vehicle (EV) parking regulations, EV infrastructure costs for new construction and retrofitting, and construction and ongoing maintenance costs for all electric buildings vs. electric and natural gas.

2. Staff presentation on commercial building energy benchmarking ordinance.

Sustainability Management Analyst Etherton gave the staff presentation. The Commissioners and staff discussed stakeholder outreach with building owners, green leasing, the costs and types of building

retrofitting vs. retrocommissioning, provisions for exceptions or waivers from the ordinance, coordination between property owners and lessees, and the anticipated ordinance implementation timeline.

Director Swiecki announced the City Council introduced the tree ordinance and initiated a zoning text amendment regarding how much garage floor area may be exempted from the floor area ratio calculation for single-family homes on substandard lots.
