After that I would like to either take a leave of absence until my wife is able to go back to work, May or June of 2016, or resign after City Council receives our recommendation. We have a second baby coming in January! I have served for 3 terms and feel honored to have been part of such an important process, but unfortunately I doubt I would be able to continue in a capacity that would best serve the City and its residence with two children at home. I am a self-employed work-at-home dad and because many of my jobs require evening work, it is difficult to make all of my meetings. This past year's work schedule has been in conflict with my Commission meetings more than expected and I don't see it letting up much. Although missing several meetings this past term did not result in a delay of any applications or other agenda items, it doesn't feel good to miss them and ultimately may reduce my effectiveness. I don't feel I have been able to contribute as much as I would like or become the Planning Commissioner I aspired to due to schedule conflicts. When I began as a Commissioner in 2010, I was employed with a much more predictable schedule. Also, in order for my wife to continue her career, I handle the majority of the late night issues with our 2-year old and will for the next baby which also caused me to miss some meetings without be able to give ample notice.

What do you feel you could contribute to the Commission/Board?

Being able to continue serving until we make our recommendation to City Council, would allow me to carry over my knowledge, empathy and objectivity to of one of the most important issues in Brisbane's history, The Baylands. I lived in Brisbane as a child, graduating from Kindergarten here in the 70s, and ultimately came back to live, work and raise my family so my passion and roots for Brisbane have long been cultivated here. That coupled with my work experience and education, two Masters degrees in Design Communication and Business Strategy, give me an unparalleled ability to see the three pillars (social, economic and environmental) of sustainability and represent our City with long-term vision.

Planning Commission meetings are held on the 2nd and 4th Thursday of each month, beginning at 7:30 p.m. There are occasional extra meetings and a substantial amount of reading material to review prior to each meeting. How much time do you envision giving to the Planning Commission? How often are you out of town? What other commitments might cause conflicts in your attendance at Commission meetings/activities or conferences?

With our new baby arriving in January, I would appreciate the flexibility of being able to continue as a Commissioner until we make our recommendation to City Council on the FEIR, where I would then resign, or take a leave of absence until later in the year. I would like to contribute my knowledge of the EIR process, the Sustainability Principles I helped develop in the Sustainability Committee, and that as a Commission of the past 5 years. And, possibly set more of a reasonable standard/expectation for work-at-home parents to serve in City government.
