# A. Authorize the Executive Director to sign the Residential Purchase Agreement for the Housing Authority to purchase Unit D, 1 San Bruno Avenue

City Attorney Roush provided a brief overview of the terms and conditions of the Housing Authority's purchase of 1 San Bruno Ave. Unit D, a property subject to a first time homebuyer loan and resale restriction agreement. He reported that staff has calculated the maximum resale price of the property as \$500,269, and the Housing Authority will need to pay off any remaining balance on the first deed of trust, and provide sellers their equity in the property, as well as a portion of the sales commission and the monthly Homeowner's Association dues until the Authority sells the property.

After further questions and Council discussion, CM Lentz made a motion, seconded by CM Cunningham, to authorize the Executive Director to sign the Residential Purchase Agreement for the Housing Authority to purchase Unit D, 1 San Bruno Avenue.

B. Approve Resolution No. 2018-64 and GVMID Resolution No. 2018-02 Authorizing Bay Area Water Supply and Conservation Agency (BAWSCA) to Negotiate Amendments to the Water Supply Agreement with the City and County of San Francisco

City Engineer Breault reported that approval of the resolutions would authorize the Bay Area and Water Supply Conservation Agency (BAWSCA) to represent the City and the Guadalupe Valley Municipal Improvement District (GVMID) in matters related to the Water Supply Agreement with the City and County of San Francisco (CCSF).

After some Council discussion, CM O'Connell made a motion, seconded by CM Davis, to approve Resolution No. 2018-64 and GVMID Resolution No. 2018-02 as it stands.

# A. League of California Cities Annual Conference Resolutions

- Support Resolution No. 1 which asks the League to explore preparation of a ballot measure or constitutional amendment to further strengthen local democracy and authority.
- Support Resolution No. 2 which asks the League to support the repeal of California Food and Agricultural Code § 11501.1 and create a task force to study the unintended negative consequences of anticoagulant rodenticides.
