## COUNCIL GOAL SETTING WORKSHOP

### A. Discussion of Workplan

City Manager Holstine explained the booklet format of the 2014 Workplan that had been distributed to Councilmembers. He said that it was organized into four major subject areas; Planning, Community Planning, Economic Development, and Financial Management.

Councilmembers reviewed and discussed the following list of issues and projects in the proposed 2014 Workplan and made additions and changes (shown in Attachment A):

## B. Discussion of Draft Baylands EIR Planning Review Process

Community Development Director Swiecki explained that with the release of the Brisbane Baylands Draft EIR in June of 2013, the community focus has been centered on the public review of the EIR.

He said the purpose of the white paper being presented to Council at this workshop, was to identify procedural options for the City to consider as it moves forward with CEQA review and City planning review for the Baylands site, including discussion of how the two processes interact. He explained that the processes described in the paper would allow for (a) the review and adoption by the City Council of updated General Plan provisions for the Baylands to define the selected mix and intensity of land uses (Concept Plan) and set general development policies for the Project Site, (b) the Council's concurrent or subsequent adoption of a Specific Plan consistent with the provisions of the updated Brisbane General Plan, and (c) certification of an EIR for development on the Baylands.

He then explained the three potential planning outcomes and referred to a diagram showing the Conceptual EIR and Planning Review Process which note that the City has the option of approving UPC's Specific Plan as proposed or with minor or major revisions, in addition to the option of denial of the plan. He also noted that the City could also use any of the other scenarios or alternatives evaluated in the EIR, or a combination of components from different scenarios/alternatives, as the basis for updated General Plan policies and a Specific Plan for the Baylands.

Mr. Swiecki then outlined the ongoing and future activities supporting the Baylands Planning Process, including preparing Fiscal and Economic Studies, preparation of the Final EIR, a Community Opinion Survey, and Sustainability Planning.

And finally, he talked about the Planning Commission Hearings and actions, the City Council hearings and actions, a potential for a City-Sponsored Planning Process, Funding for the Baylands Planning Process, and the Council's strong interest in putting the Baylands land use plan on the ballot prior to

final adoption.

After Councilmember questions, clarifications, and discussion, they noted that the document before them was still being worked on and updated and also asked that staff put together a calendar showing which things were moving forward in the process and when.

# Changes made to the Council Goal Setting Workplan

(Italicized words in red denote where a change was made or where new comments were added.)

### **Community Values**

Environmentally-Progressive – Brisbane will be a leader in setting policies and practicing service delivery innovations that promote *ecological* sustainability.

## **Planning**

- #2A Completed in 2013 Completed the context & summary approach for 10 *principles* of the Plan 2014 Objectives Complete *Implementation* Plan
  - Comment At their April 15, 2013 meeting, Council received the document, "Sustainability Goals for the Baylands" presented by the Sustainability Committee which outlines the 10 One Planet Living principles. Consultant Integral Group has been hired to develop the KPIs and Implementation Plan.
- #2B Purpose Ensure long-term financial viability of community services at the Baylands provided by the City.
- #3 Purpose Ensure that *all* new *land use and building decisions* in the City meet the Community Values and standards.
- #4 Community Values remove "Public Safety" and add Environmentally-Progressive
- #7 Purpose To ensure *operations and use* within the Quarry meets the Community's Values and standards.
- #9 Completed in 2013 Subcomm. of OSEC and PC members reviewed draft ordinance

Future Objectives – Hire architect to design

Comment - As stated previously, staff is working with the Library staff to update a proposed needs analysis which will program the space for a new library. Issues such as how much area for computers, Teen section, etc. will be evaluated. Any Council decision will come after all analyses are completed. A specific location also needs to be determined before an architect can be hired to design a new library facility, if the Council decides to move forward with a library project.

#14 Walkways (Tulare to Alvarado and Bicentennial Walkway)
Purpose: Provide safe alternatives for pedestrians and enhance walkability in the community.
Community Values — Public Safety, Involved
2014 Objectives — Preliminary design that results in a cost estimate (Tulare to Alvarado);
Investigating potential funds to complete work (Bicentennial Walkway)
Comment — Staff anticipates the Tulare to Alvarado walkway preliminary design to cost
\$25,000. Funds were not granted by the County for retrofitting Bicentennial Walkway due to the retrofit (adding a code-compliant handrail and replacing lighted bollards) making the walkway safer, but not handicap-accessible. Retrofitting Bicentennial Walkway is estimated to cost
\$50,000.

### #15 Public Arts Ordinance

Purpose: Develop a method to ensure public art is an integral component of the community. Values: Informed, Fiscally-Conservative, Involved

Completed in 2013 – Council reviewed and referred to Public Arts Subcommittee, which reviewed draft ordinance and referred to Planning Commission (1/13/2014)

2014 Objective – Identify potential grant funding

Comment - In September 2012, the Parks & Recreation Commission created a Public Art Funding Subcommittee. In November 2012, the City Council directed the Parks & Recreation Commission to draft an ordinance, which the subcommittee did with assistance from staff and the City Attorney. It was determined that the ordinance itself would be more of a shell, talking about how revenues are taken in, with the Implementation Guidelines done as a separate document, which would give the Council the most amount of flexibility to make changes if needed rather than go through an ordinance method.
