SUBJECT: Status Report on FY14-15 "mini CIPs"

DATE: August 20, 2015

Purpose: This report provides an update on the "mini" capital improvement projects

(CIPs) approved in the city's Fiscal Year 2014-2015 budget.

**Recommendation:** Informational only, no action required.

#### **Background:**

The city's Public Works Department (DPW) is composed of thirteen separate, diverse departments, and provides support to other city departments. The recession experienced across the nation in the first decade of 2000 resulted in many years of budget tightening, with spending focused on operational issues and emergency repairs. During this time, DPW saw a 20% reduction in its O&M staff and a 40% reduction in its Engineering staff.

The 2014-2015 budget included \$1.5M for thirty-four (34) mini CIPs. As of the date of this staff report, \$1.2M of the work is completed, and all of the work is underway. All of the mini CIPs are anticipated to be completed within the approved budget.

A listing of the projects and their status, as well as select photos, is attached.

The oversight, design, and construction of these projects was in addition to managing daily operational issues, responding to an ever increasing regulatory environment, and managing major CIPs such as the Marina dredging, and the undergrounding of the 8" force main on Bayshore Boulevard (the design is complete, and the Notice Inviting Bids will be issued such that construction will be complete July 2016).






