#### MEETING CALLED TO ORDER/ROLL CALL

The meeting was called to order at 9:31 a.m. All Boardmembers were present.

### **PUBLIC COMMENT**

There were no members of the public wishing to speak.

## **NEW BUSINESS**

- a. Consider adoption of the following resolutions:
  - 1. Approve Resolution No. OB 2015-04 approving the Successor Agency's repayment of a loan owed to the former Agency's Low and Moderate Income Housing Fund in accordance with Health & Safety Code Section 64171 (d)(1)(G) and rescinding Resolution No. OB 2015-03

- 2. Approve Resolution No. OB 2015-05 approving the Successor Agency's Repayment of a loan owed to the former Agency's Low and Moderate Income Housing Fund in accordance with Health & Safety Code Section 34171 (d)(1)(G)
- 3. Approve Resolution No. OB 2015-06 approving the Recognized Obligation Payment Schedule for the Jan 1<sup>st</sup>-June 30<sup>th</sup>, 2016 Six-month fiscal period (ROPS 15-16B), and making related findings and declarations and taking related actions in connection therewith

Deputy Finance Director Cooper explained the information provided in the staff report. She said that Resolution No. OB 2015-04 was correcting the effective date of the originally adopted Resolution No. OB 2015-03 which sets for the SERAF Debt Repayment Schedule for repayment of a loan owed to the former Agency's Low and Moderate Income Housing Fund. She indicated that the loan amount was for \$572,509.33.

She said that the second Resolution, No. OB 2015-05 was approving the Low and Moderate Income Housing Fund Repayment Schedule of the deferred set-aside owed to the former Low and Moderate Income Housing Fund. She indicated that the loan amount was for \$4,099,278.

Ms. Cooper said that the third Resolution, No. OB 2015-06 was to adopt the Recognized Obligation Payment Schedule for the period of January 1<sup>st</sup>- June 30<sup>th</sup>, 2016, which included regular bond payments, SERAF loan payments, 20% set aside, and other administrative expenses.

After Boardmember questions and clarifications, it was decided that Resolution No. OB 2015-05 would be brought back to the next Oversight Board Meeting pending corrections and updating of the attached payment schedule.

After Boardmember questions and clarifications it was decided to not include the Housing Fund payment on the 15-16B ROPS. Boardmember Miller also asked that the sixth "Whereas" in Resolution No. OB 2015-04 make a reference to Redevelopment Area 2.

With that change, Boardmember Blackwood made a motion, seconded by Boardmember Leiter, to adopt the Resolution No. OB 2015-04 as amended. The motion carried unanimously by all present.

Boardmember Blackwood made a motion, seconded by Boardmember Leiter, to adopt Resolution No. OB 2015-06 as amended. The motion carried unanimously by all present.

# c. Approval of Minutes of February 11, 2015

Boardmember Miller made a motion, seconded by Boardmember Blackwood, to approve the minutes as presented. The motion carried unanimously by all present.

# d. Future Meeting Dates and Agenda Items
