ADOPTION OF AGENDA (Deletions, Additions, Changes and Adoption)

CM Richardson proposed moving Consent Calendar Item M to the beginning of the agenda. CM Waldo made a motion, seconded by CM Lentz, to adopt the agenda as amended. The motion was carried by all present.

**B. Bert Ganoung, Manager, Aircraft Noise Abatement
San Francisco International Airport**

Mr. Ganoung gave a presentation on the Aircraft Noise Abatement statistics and efforts.

Jenna Corlett, student at Lipman Middle School spoke about the noise levels while in class

Barry Corlett, questioned whether it was the FAA that makes the rules.

Peter Grace had questions regarding the different runways and departure routes

Ana Maria Hernandez questioned the information that was presented.
