CALL TO ORDER - FLAG SALUTE

Mayor Bologoff called the regular meeting to order at 7:30 p.m. and led the flag salute.

ADOPTION OF AGENDA (Deletions, Additions, Changes and Adoption)

CM Waldo made a motion, seconded by CM Conway, to adopt the agenda as proposed. The motion was carried unanimously by all present.

PRESENTATION

- A. Kinder Morgan – Tank Farm Safety**
Alan Campbell, Director of Project Permitting
Nicole Stewart, Area Manager, Brisbane Terminal & Richmond Terminal

Mayor Bologoff introduced Mr. Alan Campbell and Ms. Nicole Stewart from Kinder Morgan. Mr. Campbell gave a presentation outlining their company's history and operations. Councilmembers asked extensive questions about the Brisbane facility, its safety, and its aesthetics.

Glen Allenson spoke of his concern regarding past leaks and its current safety.

Clara Johnson spoke of her concern regarding hydro-carbons and aesthetics and urged the Council to get aggressive with enforcement.

John Burr said the tank farm has been a long-time public nuisance and should be abated.

Councilmember's requested that Mr. Campbell respond in writing to the questions that had arisen and be available to meet with Council and member of staff as needed. Mr. Campbell assured that he would be happy to do that.

ORAL COMMUNICATIONS

San Bruno Vice Mayor Michael Salazar presented a proclamation expressing appreciation to the City of Brisbane for assistance provided in response to the September 9, 2010 explosion and fire.

Mayor Bologoff thanked him for his presentation and acknowledged the Brisbane staff member's who helped out in the crisis.

ORAL COMMUNICATIONS


There were no members of the public wishing to speak.
