# PRESENTATION

# A. Wildland Fire Evacuation Drill Update – May 21, 2011

Public Works Director Breault and Deputy Chief Panacci gave Council an update on the changes to the annual Wildland Fire Evacuation Drill.

# ADOPTION OF AGENDA (Deletions, Additions, Changes and Adoption)

Councilmembers asked that the meeting be closed in memory of former San Carlos Mayor Omar Ahmad and longtime Brisbane resident Gary Apotheker. CM Conway made a motion, seconded by CM Waldo, to adopt the agenda as amended. The motion was carried unanimously by all present.

CM Richardson made a motion, seconded by CM Conway, to adopt the Consent Calendar as proposed. The motion was carried unanimously by all present.

# **PUBLIC HEARING**

A. Hear public testimony and increase assessments to pay for the services required if there is not a majority of voters protesting the increase - Sierra Point Landscape and Lighting District - Proposed Assessment Increase

Administrative Services Director Schillinger outlined the proposed assessment increase and public hearing process. Mayor Bologoff opened the public hearing and asked the City Clerk to give the results of the tabulation of votes. City Clerk Spediacci advised that the majority of landowners voted in favor of the increase. There being no members of the public wishing to speak, the public hearing was closed. CM Conway made a motion, seconded by CM Richardson, to approve the proposed increase. The motion was carried unanimously by all present.

#### **NEW BUSINESS**

A. Consider introduction of Ordinance No. 560, amending Subsection 13.08.020.D and subsection 13.12.020.C of the Municipal Code concerning increases in Sewer and Water Service Charges

City Attorney Toppel outlined the purpose of the proposed Ordinance. After Councilmember questions and clarifications, CM Conway asked that the Ordinance be modified to state the purpose in the beginning of the Ordinance. He then made a motion, seconded by CM Lentz, to introduce the Ordinance as amended. The motion was carried unanimously by all present.

B. Consider introduction of Ordinance No. 561, amending Sections 15.22.040 and 15.22.060 of the Municipal Code to Increase the Limit for Informal Bidding

City Attorney Toppel outlined the purpose of the proposed Ordinance. After Councilmember questions and clarifications, CM Conway made a motion, seconded by CM Richardson, to introduce the Ordinance as proposed. The motion was carried unanimously by all present.

C. Consider authorizing the City Manager to execute a contract with Camp Dresser & McKee Inc. (CDM) to review a facilities operation plan for a soils processing facility operating at the Brisbane Baylands and to develop and implement a compliance auditing program

Community Development Director Swiecki outlined the purpose of the proposed contract. After Councilmember questions and clarifications, CM Conway made a motion, seconded by CM Richardson, to authorize the execution of the contract as proposed. The motion was carried unanimously by all present.

D. Consider authorizing the Mayor to send a letter to ABAG expressing the City's concerns with the Initial Vision Scenario

Community Development Director Swiecki outlined the purpose of the proposed letter. After Councilmember questions and clarifications, CM Conway thanked the Open Space and Ecology Committee for their comments on the Initial Vision Scenario. CM Conway made a motion, seconded by CM Waldo, to authorize the Mayor to send a letter to ABAG as proposed. The motion was carried unanimously by all present.

E. Consider directing staff to bring back a resolution increasing the Brisbane Marina berth fees for both regular single and double finger berths by 2%, and open the public comment period

Harbormaster Warburton outlined the purpose of the proposed increase.

<u>Bill Demeter</u> of South San Francisco protested the increase and asked that repairs and maintenance be completed at the Marina.

After Councilmember questions and clarifications, CM Waldo made a motion, seconded by CM Richardson to direct staff to bring back a resolution as proposed. The motion was carried unanimously by all present.
