CM Conway made a request to close the City Council Meeting in memory of Cleo Marshall. CM Conway made a motion, seconded by CM O'Connell, to approve the agenda as amended. The motion was carried unanimously by all present.

After more Council discussion, CM Davis added she will forward a presentation she received from the member of the public about his interest in establishing a business possibly on 1 San Bruno.

Mayor Liu stated that she would not like to see adult only shops on 1 San Bruno because she would like to see something the entire community can enjoy.

Denise Gregory agreed with Mayor Liu's statement.

Michelle Dizitser thanked the Council and offering herself as a resource.

CM O'Connell made a motion, seconded by CM Lentz, to approve Consent Calendar Item F as amended. The motion was carried unanimously by all present.

## G. Adopt Resolution No. 2017-41 amending FY 2017-18 Capital Improvement Program to Include Tunnel Avenue Rehabilitation Project

Tony Verreos asked why spend \$300,000 and whether the project can be done at a later time

<u>Anja Miller</u> said it is nice to see something done on Tunnel but did not like having this item on Consent Calendar. Secondly UPC should make it safe for bicyclists around their property.

<u>Dana Dillworth</u> asked why the City is not dealing with and prioritizing Lagoon Way or Sierra Point Pkwy. These are areas are more unsafe.

<u>Barbara Ebel</u> stated that this area needs to be safer for cyclists and that the Community would like information ahead of time.

After more Council questions and discussion with City Engineer Breault, CM Conway made a motion, seconded by CM O'Connell, to approve Consent Calendar Item G. The motion was carried unanimously by all present.

## I. Adopt Resolution No. 2017-46 authorizing Execution of Cooperation Agreements with San Mateo County for participation in the Housing and Community Development Programs

Barbara Ebel stated that the language in this agreement is too vague.

City Manager Holstine reported that this agreement allows small cities like Brisbane to apply for community development grants. The City has not applied for grants in a while but possibly in the future.

<u>Anja Miller</u> warned that our city was founded by preventing Urban Renewal and this agreement is cooperating with the County for Urban Renewal.

<u>Tony Verreos</u> stated that it is difficult to understand this agreement and supports it as long as there is no obligation.

After further Councilmember questions of staff, City Manager Holstine said he will ask staff to prepare a report of what funds are available.

Mayor Liu asked if staff would look into if the City can get funding for Brisbane Village helping hands.

CM Davis asked if staff can research if we can get funding for tiny home project.

CM Conway made a motion, seconded by CM Davis, to approve Consent Calendar Item I. The motion was carried unanimously by all present.

#### J. Adopt Resolution No. 2017-43 and support the Home For All San Mateo County Initiative

CM O'Connell stated that she felt this is a lofty goal and aspirational and she was not sure if there were any benefits to passing this resolution at this time.

City Manager Holstine stated that Home for All is a program that the County is supporting to provide technical support and resources. There is no commitment for development.

Mayor Liu said that she is attending these County meetings and adopting this resolution shows a good faith effort from our City.

Council directed staff edit the document and use "strive" instead of committed in the last WHEREAS and the last paragraph.

CM Lentz made a motion, seconded by CM Davis, to approve Consent Calendar Item J as amended. The motion was carried unanimously by all present.

# K. Approve Memorandum of Friendship City Relationship between Panyu District of Guangzhou City, the People's Republic of China and the City of Brisbane

<u>Anja Miller</u> stated that this agreement should be certified by a translator. She also stated that the Sister City relationship with Brisbane, Australia was a student exchange program and not a business exchange. She requested the Council postpone their decision on this.

<u>Dana Dillworth</u> stated that she has a problem with language of the document especially since it seems that we are promoting tourism with the other entity.

<u>Tony Verreos</u> said there is alternative ways Brisbane businesses can get connections to China if they want to expand their businesses there.

<u>Anja Miller</u> shared that the Brisbane Chamber of Commerce is more appropriate and have already created relationships.

<u>Denise Gregory</u> agreed with people that spoke and liked the idea of Sister Cities not on a business scale.

<u>Carolyn Parker</u> suggested the City should pull this item until the Citizens of the Community know more about what it means to be a Friendship city.

Mayor Liu stated that this is just an expression of international cooperation. This could also be an opportunity for cultural exchanges.

CM Lentz agreed that this is just a standard agreement.

CM O'Connell stated that she would not want to enter our City into this agreement for three years. It's more appropriate for Chamber of Commerce, Lion Clubs, Rotary clubs, etc. to enter into this agreement.

After further Council discussion, CM Lentz suggested to tinker with the language and receive more information about this city.

CM Davis agreed and requested staff to come back to do a report and what the city is about and what kind of trade they do. Additionally ask the City what this agreement means to them.

CM Conway made a motion, seconded by CM Davis, to table Consent Item K. The motion passes unanimously by all present.

CM Davis added she wanted more information on the agreement with the Chamber and discuss further what we would like to see in a Friendship City relationship.

CM Conway added that he would prefer a staff report with public comment.

Mayor Liu also requested staff to look into what other relationships cities in the County have.

Barbara Ebel stated that she is not in support of wasting staff time.

Mayor Liu shared that a delegation is coming sometime this year.

CM Davis- that would be a good opportunity to have the exchange after that delegation visit.

## L. Authorize the Mayor to sign a letter taking an Oppose Position on Senate Bill 649 on Wireless Telecommunications Facilities

City Engineer Breault reported that the revised League of Cities recommendation was to not send the letter as it was addressed to the Assembly Appropriations Committee because the Committee had already passed the bill. The recommendation from the League was that we were past the point of letters being useful and that direct contact with Assemblymember Kevin Mullin was the most productive route as the bill is expected to be on the floor this week. The Mayor will be contacting Assemblymember Kevin Mullin regarding the City of Brisbane taking an oppose position on Senate Bill 649.

CM Conway made a motion, seconded by CM Lentz, to approve Consent Calendar Item L as amended. The motion was carried unanimously by all present.

# M. Approve Resolution No. 2017-40 confirming the City's commitment to safeguard the civil rights, safety and dignity of all community members

CM Davis stated that she was disappointed this item was under Consent Calendar. She shared that Cities like Sacramento and Stockton were still concerned about losing Federal funding because of the appearance of being a Sanctuary City. She had suggested Striking Sections 2 and Sections 3 of the document because the language may imply Brisbane is a Sanctuary City.

After CM Davis made a motion, seconded by CM Lentz, to approve Consent Calendar Item M as amended. The motion was carried unanimously by all present.

#### A. Discuss and Consider City Hourly Employee Pay Schedule

## B. Adopt Resolution Nos. 2017-44 and 2017-45 to Increase the Hourly Pay Rate for the Recreation Leader and Senior Recreation Leader Position

Administrative Services Director Schillinger reported that not many apply for Recreation positions because the salary is low and employment is good right now.

He said it is being recommended to adopt Resolution No. 2017-44 regarding the Pay Scale for the Hourly Employees to reflect the increase hourly pay rate for the Recreation Leader and Senior Recreation Leader Position and to adopt Resolution 2017-45 to approve updating the Master Pay Schedules for all employees. The cost to the City will be approximately \$40,000.

After City Council discussion and questions of staff, CM Lentz made a motion, seconded by CM Davis, to adopt Resolution No. 2017-44 and Resolution No. 2017-45. The motion was carried unanimously by all present.

#### A. Consider approval of Memorial Bench & Plaque Policy

Recreation Coordinator Franco is asking the Council to review and consider adopting the proposal from the Parks & Recreation Commission for a policy to guide requests for the placement of commemorative benches with plaques in the City of Brisbane. The fee for memorial benches would be established each year by the Master Fee Schedule. The initial memorial bench commemoration fee is being proposed at \$1,500.

After some Council discussion and questions of staff, CM Davis stated that she did not like the aesthetics of the benches.

<u>Tony Verreos</u> said that if somebody pays \$1500 for a plaque then the bench should be anchored. He also stated that there has been precedent of placing names and businesses on Playground Stars and Skatepark bricks.

After further Council discussion, CM Conway made a motion, seconded by CM Lentz, to approve Memorial Bench and Plaque Policy. The motion was carried unanimously by all present.

F. Authorize publication of the Notice Inviting Bids for construction of the Annis Road Pressure Regulating Valve Station and Fire Main Replacement Project.

City Engineer Breault stated that the purpose of this project is to provide fire flow capacity per the 2016 California Fire Code criteria within the benefitting neighborhoods and presented a few slides regarding the Project.

After City Council questions of City Engineer Breault, CM Conway made a motion, seconded by CM Lentz, to approve the Publication of the Notice Inviting Bids for construction of the Annis Road Pressure Regulating Valve Station and Fire Main Replacement Project. The motion was carried unanimously by all present.

He said that the majority of the roof is designed so we have room for a photovoltaic system and believes the City will receive good pricing on this project.

An unnamed citizen stated that LED lights can also help with this project.

After further Council questions of staff, CM O'Connell made a motion, seconded by CM Davis, to approve the Publication of the Notice Inviting Bids for the Roof-Mounted Photovoltaic System for City Hall. The motion was carried unanimously by all present.
