ADOPTION OF AGENDA (Deletions, Additions, Changes and Adoption)

CM O'Connell made a motion, seconded by CM Davis, to adopt the agenda as amended. The motion carried unanimously by all present.

PRESENTATION

A. Receive Brisbane Library FY 16/17 Annual Report from Francisco Vargas, Library Manager for Brisbane

Francisco Vargas, Library Manager for Brisbane, presented the Brisbane Library FY 16/17 Annual Report. He highlighted their accomplishments for the year.

After some questions, Councilmembers thanked Mr. Vargas for his presentation and the library's services to the community.

B. Receive Presentation from Get Us Moving San Mateo County

Cory Wolbach, Outreach Manager, of Get Us Moving San Mateo County made a presentation on Get Us Moving San Mateo County. Get Us Moving San Mateo County is a diverse coalition of regional leaders, transportation experts, nonprofit groups, businesses and volunteers that are coming together to find a solution to San Mateo County's complex transportation issues. Mr. Wolbach encouraged residents of Brisbane to take part in their community survey to help build the roadmap for a faster, better transportation system in San Mateo County.

PUBLIC HEARING

- A. Consider Introduction of Ordinance No. 624 (Zoning Text Amendment RZ-3-17) – Zoning Text and Map Amendments to Adopt Housing Overlay Zones PAOZ-1 and PAOZ-2 to implement the Parkside at Brisbane Village Precise Plan**

Community Development Director Swiecki reported that the purpose of Ordinance No. 624 is to implement the Parkside at Brisbane Village Precise Plan by adopting zoning text and map establishing Parkside Overlay Zones (PAOZ-1 and PAOZ-2) for housing.

After some City Council discussion and questions of staff, Mayor Conway opened the public hearing. No member of the public wished to speak. CM O'Connell made a motion, seconded by CM Cunningham, to close the public hearing. The motion was carried unanimously by all present.

CM O'Connell made a motion, seconded by CM Lentz, to introduce Ordinance No. 624. The motion was carried unanimously by all present.

NEW BUSINESS

A. Consider Providing Direction to Staff regarding Zoning Ordinance Provisions Pertaining to Minimum Distance of Cannabis Businesses from Schools and Daycare Facilities

Community Development Director Swiecki reported that the purpose of this discussion is to determine whether the Council wishes to Provide Staff direction regarding a Zoning Text Amendment to Consider Amending Brisbane Municipal Code (BMC) Chapter 17.33 regarding the Prohibition of Cannabis Businesses within 600 feet of a School or Daycare Facility.

After some Council questions of Associate Planner Capasso and Community Development Director Swiecki, Council directed staff to return with a zoning text code amendment to exclude Crocker Park from the 600 foot buffer requirement that requires new cannabis businesses to be located more than 600 feet from schools, daycares, or youth centers.
