NEW BUSINESS

A. Consider adoption of Resolution No. HA 2018-01, a resolution of the Brisbane Housing Authority of the City of Brisbane approving a sale of lots identified by the County Assessor as Parcel Numbers 007-566-010, 007-560-130, -140 and -120 to JL Homeland Development Group.

City Attorney Roush reported that if adopted, this Housing Authority Resolution 2018-01 will approve the sale of four contiguous, vacant, lots, with a total land area of approximately 4.22 acres, located immediately south of the intersection of San Bruno Avenue and Gladys Avenue in Brisbane, CA. The lots will be sold to JL Homeland Development Group and are identified by the County Assessor as Parcel Numbers 007-566-010, 077-560-130, -140 and -120.

After Council comments and questions of City Attorney, Authority Member O'Connell made a motion, seconded by Authority Member Cunningham, to adopt the Resolution No. HA 2018-01. The motion was carried unanimously by all present.

B. Consider Adoption of Resolution 2018-06 amending the Building Permit Fee Schedule for Non-Residential Rooftop Solar Installations

Community Development Director Swiecki reported that the purpose of this Resolution is to establish the fee for non-residential rooftop solar installations to \$1,000 for systems up to 50 kilowatt (kW), plus \$7/kilowatt for each kW between 51kW and 250kW, plus \$5/kilowatt per kW above 251kW.)

CM Lentz made a motion, seconded by CM Cunningham, to adopt the Resolution No. 2018-06 amending the Building Permit Fee Schedule for Non-residential Rooftop Solar Installations. The motion was carried unanimously by all present.

C. Consider Introduction of Ordinance 621, waiving first reading, amending Title 10 of the Municipal Code concerning "Vehicles and Traffic"

City Engineer Breault reported that the purpose of Ordinance 621 is to revise the "white line" parking restrictions so that violation on lower streets is punishable by citation, rather than towing. The ordinance will also create parking regulations for electric vehicle charging stations.

After some Council discussion and questions of City Engineer Breault and Police Chief Macias, CM O'Connell made a motion, seconded by CM Lentz, to introduce Ordinance 621 amending Title 10 of the Municipal Code concerning "Vehicles and Traffic". The motion was carried unanimously by all present.
