#### **PUBLIC HEARING**

A. Consider Introduction of Draft Ordinance No. 642 (Zoning Amendment RZ-3-18)
Zoning text amendment to the TC-1 District regulations (BMC Chapter 17.19) to allow limited outdoor storage of North County Fire Authority-approved flammable materials in Crocker Park subject to the granting of an Exception Permit by the Zoning Administrator.

Community Development Director Swiecki reported that the purpose of this ordinance is adopt regulations to allow for safe and code-compliant outdoor storage of specified flammable materials in the Crocker Industrial Park.

The proposed ordinance would allow businesses in the Crocker Industrial park to apply for an Exception Permit from the Zoning Administrator to store outdoors only flammable materials specifically authorized by North County Fire Authority.

Community Development Director Swiecki added that North County Fire outdoor storage of flammable materials, when properly housed, is preferable from a public safety perspective.

After some Council questions, Mayor Davis opened the public hearing.

No members of the public wished to speak.

CM Conway made a motion, seconded by CM Cunningham, to close the Public Hearing. The motion was carried unanimously by all present.

City Engineer Breault reported that the purpose of this item is to accommodate previously approved commercial development in the Sierra Point area.

It is being recommended that following the close of the public hearing, adopt the resolutions, one vacating portions of the public rights of way in the Sierra Point area, and the other, authorizing the conveyance to HCP LS Brisbane of 1) a portion of a City owned parcel in the Sierra Point area and 2) the vacated rights of way, and reserving and accepting easements for pedestrian access and

public utility purposes, and for underground waterline purposes, on the properties conveyed to HCP.

After further comments, Mayor Davis opened the Public Hearing.

Barbara Ebel asked why there was a need for land for setbacks.

Administrative Services Director Schillinger reported that on March 7, 2019 the City Council approved \$25,000 from the Public Art fund to be used to place art on or near the quarter pipe wall facing Old County Road. The Art Selection Committee reviewed eight proposals and narrowed it down to the firm Science and Company to paint a mural on the quarter pipe wall at the skateboard park.

Resolution of the League of California Cities Calling on the California Public Utilities Commission to Amend Rule 20a to Add Projects In Very High Fire Hazard Severity Zones to the List Of Eligibility Criteria and to Increase Funding Allocations for Rule 20a Projects

The Second Resolution is:

A Resolution Calling Upon the Federal and State Governments to Address the Devastating Impacts of International Transboundary Pollution Flows into the Southernmost Regions of California and the Pacific Ocean

After some Council discussion, Mayor Davis will support both resolutions.
