## D. Discussion and Consider making Appointments for two Public Art Advisory Committee terms through January 2020

Since CM Davis recused herself from this item, Mayor Conway moved up the discussion of Agenda Item D ahead of Agenda Item C.

CM Cunningham stated she would like to appoint all three interviewees. She added that in order to change the Public Art Advisory Committee membership from two to three appointed members from the community, the Council must consider amending the Public Arts Implementation Guidelines adopted at the City Council Meeting of July 20, 2017.

<u>Kevin Fryer</u>- current Parks and Recreation Commissioner, commented that according to the current guidelines, the Public Art Advisory Committee will consist of 3 members from the Parks and Recreation Commission, two members of the City Council, and two members from the Community at-large at least one needs to be professionally engaged in the art community and at least one must be an employee or owner of a business located within Brisbane.

CM O'Connell stated that she would be interested in having a discussion on changing the number of community members in the Public Art Advisory Committee at the next City Council meeting but would like to keep the Committee to an odd number member committee.

After some Council discussion, CM O'Connell made a motion, seconded by CM Lentz, to appoint Camille Salmon and Danette Davis to the Public Art Advisory Committee term through January 2020. The motion was carried by a 4-0-1 vote. CM Davis recused herself from this item due to a conflict of interest and left the room.
