#### CITY COUNCIL REGULAR MEETING

#### **NOVEMBER 15, 2010**

#### CALL TO ORDER - FLAG SALUTE

Mayor Conway called the regular meeting to order at 7:30 p.m. and led the flag salute.

#### ADOPTION OF AGENDA (Deletions, Additions, Changes and Adoption)

CM Bologoff asked to remove Item C from the Consent Calendar and continue the matter to the December 6<sup>th</sup> meeting pending the results of the Closed Session Item on the agenda later.

Mayor Conway asked to add one case of exiting litigation with the San Mateo County Community College District to Closed Session.

CM Richardson made a motion, seconded by CM Bologoff, to adopt the agenda as amended. The motion was carried by all present.

#### PRESENTATION & PROCLAMATION

A. Presentation from PG&E regarding Gas Line Inspection Program

Government Representative Ashley Simpson introduced Rick Solis who reviewed the location and the inspection program of Brisbane's gas lines. Ms Simpson reviewed the 20/20 Pipeline Replacement Program and said that Brisbane was due for replacement by 2015. After extensive Council discussion and questions, Ms Simpson agreed to send a letter to the Council assuring that Brisbane would be apart of the replacement piping project in 2015 and send laminated business cards to each Councilmember. Mr Solis assured the Council that the current pipes were regularly inspected and in good shape.

<u>John Christopher Burr</u> suggested that Brisbane do their own investigation and demand replacement of older lines.

## B. Proclamation honoring Veterans and Veterans Day

Mayor Conway read the proclamation and presented to Public Works Director Breault, a recent veteran, on behalf of all veterans.

#### PUBLIC HEARING

A. Consider introduction of Ordinance No. 551 adopting the 2010 Edition of the California Fire Code, with local modifications and introduction of Ordinance No. 552, adopting the 2010 Edition of the California Building Standards Code

City Attorney Toppel outlined the purposed of the adoption of the two Ordinances. After Council questions and clarifications, CM Richardson made a motion, seconded by CM Bologoff, to introduce Ordinance 551 and Ordinance 552 as proposed. The motion was carried by all present.

City Manager Holstine reported on the Airport Noise Issue and the follow up meeting in early December, the High Speed Rail Project, and the Baylands EIR review. City Attorney Toppel also spoke about the Baylands EIR process and said he would send a memo to Council outlining the process.

#### A. Subcommittee Reports

CM Richardson gave an update on the Airport Noise issue and pleaded for citizens to keep calling and e-mailing the Airport Noise Complaint center, as well as attend the meeting in Millbrae on Wednesday, December 1<sup>st</sup>. She reported on the High Speed Rail meeting and her recent attendance at the concerned citizens group. She also reported that Brisbane would be hosting the Council of Cites dinner on May 27, 2011.

B. Consider forming a Council Subcommittee to give staff direction on use of discretionary funds from Seton Medical Foundation for use in Brisbane for health-related programs and/or activities

After some discussion, Council decided that the current Council Finance Subcommittee would meet to address this issue.
