CALL TO ORDER/FLAG SALUTE

Mayor Conway called the regular meeting to order at 7:31 p.m. and led the flag salute.

ADOPTION OF AGENDA

City Attorney Toppel asked Councilmembers to add an a Weed Abatement Public Hearing to the agenda as a matter that would be continued to the regular City Council meeting of June 21, 2010.

CM Waldo made a motion, seconded by CM Lentz to adopt the agenda as amended. The motion was carried unanimously by all present.

ORAL COMMUNICATIONS NO. 1

<u>Terry O'Connell</u> spoke regarding her concerns about the Universal Paragon Proposal Informational Seminar held recently. She asked if the City had heard anything from the State regarding the High Speed Rail Plan. And finally she thanked those who supported the Pancake Breakfast yesterday.

PRESENTATION

A. Jean Fraser, Chief Community Health Planner, San Mateo County

Interim Community Development Director Swieki indicated that Jean Fraser was unable to make it but Kathleen Baker, a San Mateo County Community Health Planner was here to give the presentation in her place.

Ms Baker gave a presentation on Community Health Planning as it relates to the choices that communities make in their planning processes.

After asking for further clarifications, Councilmembers thanked Ms Baker for her informative presentation.

B. Approve Monthly Investment Report as of April 30, 2010

<u>Clara Johnson</u> questioned two of the fund balances that had been temporarily in the negative on the Investment Report.

Finance Director Schillinger explained the accounting procedure that explained this temporary occurrence.

F. Approve Resolution No. 2010-26 adding the classification of Special Consultant to the class specification manual and Adopt Resolution No. 2010-27 amending Resolution No. 2001-27, the Pay Scale for Hourly Employees, adding the classification Special Consultant

<u>Clara Johnson</u> question the pay scale and title of the proposed new classification

<u>Terry O'Connell</u> also questioned the pay scale and the educational and experience requirements.

City Manager Holstine explained the rational for the proposed pay scale and education and experience requirements.

After some discussion the Council decided to change the description of the position from "Special Consultant" to "Special Assistant". CM Richardson made a motion, seconded by CM Lentz to approve Item F as amended. The motion was carried by all present.

CM Waldo then made a motion, seconded by CM Lentz, to approve Item B as proposed. The motion was carried by all present.

PUBLIC HEARING

A. Receive any protests on 2010 Weed Abatement Program Assessments

Mayor Pro Tem Bologoff asked if there was anyone from the public wishing to protest the assessments. There being no protests, CM Waldo made a motion, seconded by CM Lentz, to continue this item to June 21, 2010.

B. Consider introduction of Ordinance No. 543, waiving first reading, adding Chapter 15.72 to the Municipal Code to establish indoor water conservation regulations and introduction of Ordinance No. 544, waiving first reading, amending Chapter 15.70 of the Municipal Code establishing water conservation in landscaping regulations

Interim Community Development Director Swiecki noted that this item had been continued from the

May 17th City Council Meeting. He then reviewed the ordinances and answered the questions and concerns that Councilmember's had raised at the last meeting. He recommended approval of the ordinances.

Mayor Pro Tem Bologoff opened the public hearing.

Clara Johnson expressed her concern that the program not interfere with people's privacy.

CM Waldo made a motion, seconded by CM Richardson to close the public hearing. The motion was carried by all present.

After Council questions and clarifications, CM Richardson made a motion, seconded by CM Waldo, to introduce the ordinance as proposed. The motion passed 3-1, CM Bologff opposed.
