C. Authorize the Mayor to execute an agreement with David R. Kalb, AIA, Architect to prepare a concept plan for the Brisbane Aerie of the Fraternal Order of the Eagles as the first concrete step in the possibility of a land swap deal that could facilitate the construction of a new public library in the 100 block of Visitacion Avenue

CM Waldo made a motion, seconded by CM Richardson to approve the Consent Calendar as proposed. CM Bologoff abstained on Item A. The motion was carried unanimously by all present.

#### **OLD BUSINESS**

A. Consider adoption of Urgency Ordinance No. 550 to establish a moratorium on the establishment of businesses that perform tattooing, body piercing and permanent cosmetics, under the term "Body Art Establishment" in the NCRO, Neighborhood Commercial District

City Attorney Toppel reviewed the background and information in the staff report. After Council clarifications, CM Richardson made a motion, seconded by CM Bologoff, to adopt the Urgency Ordinance as presented. The motion was carried by all present.

# **NEW BUSINESS**

A. Consider request to defer the Fire Service Capacity Charge for 298 San Bruno Avenue

Public Works Director/City Engineer Breault reviewed the proposal outlined in the staff report. CM Richardson expressed her desire to accept the proposal in the version that included collecting interest. Mr. Joe Caldwell, Executive Director of the Baptist Church agreed to the ability to pay the charges with interest. After Council questions and clarifications, CM Richardson made a motion, seconded by CM Waldo, to approve the request with interest. The motion was carried unanimously by all present.
